1 Objective of the Meeting

A pre-bid meeting was held at 1100 Hours on 15 April 2025 in the office of Chief Engineer, Contracts (WAPDA), WAPDA Project Office, WAPDA Colony, Choochang, for the purpose of Clarification of the Bidding Documents by prospective bidders in compliance of Sub-Clause ITB 7.4 of Instructions to Bidders of the Bidding Documents.

3 Discussion Points

WAPDA welcomed the prospective bidder and explained the order of proceedings. WAPDA explained that the purpose of the meeting was to briefly explain the Bid Documents and receive clarifications of the queries raised by the prospective bidders.

WAPDA and DHC also informed the prospective bidder he may undertake a Site Visit to familiarize himself with the physical requirements of the Works and to determine a proper method of construction and adequately price the Bid.

The bidder inquired about Taxes. WAPDA and DHC informed the bidder that pursuant to ITB Sub-Clause 14.7, all duties, taxes, and other levies payable by the Contractor under the Contract, or for any other cause, as of the date 28 days prior to the deadline for submission of Bids, shall be included in the rates and prices and the total Bid price submitted by the Bidder.

The Consultants (DHC) provided a detailed overview of the Bidding Documents and highlighted key aspects that bidders should consider while preparing their bids.

WAPDA concluded the meeting and reminded the bidder that any further queries may be submitted in accordance with ITB Sub-Clause 7.1, read in conjunction with BDS Sub-Clause 7.1. WAPDA also thanked the bidder for his participation and interest in the project.
