

3. **Delivery Period:** The items on order are urgently required, so efforts should be made to deliver the same as early as possible, but not later than as mentioned in Sr. # - 1.
4. **Payment:** 100% payment on completion of supply, installation / provision of safety materials regarding prevention of COVID-19 pandemic at Dasu, District Kohistan (Upper) and on the production of the following documents:
 - i. Your Bill in triplicate
 - ii. Warranty Certificate
 - iii. Receipt / Inspection certificate issued by the Purchaser
5. **Sales Tax & Other Taxes/Government Duties:** The above rates are inclusive of all taxes and duties imposed by the Government.
6. **Warranty Certificate:** You will furnish a warranty certificate, certifying that the materials conform exactly to the specifications as laid down on the purchase order and are brand new and that in event of the material being found defective or not conforming to the specifications / particulars at the time of delivery, the unacceptable materials shall be substituted with acceptable materials at your expense and cost.
