The Government of Pakistan has obtained a credit from the World Bank for Dasu Hydropower Project (Stage-I). Part of the proceeds of the Credit would be utilized towards, the project's "Communication Plan" to disseminate project related information to the public & stakeholders.

Pakistan Water & Power Development Authority (WAPDA) intends to procure through World Bank's shopping procedure, **“Installation of a Surface Mounted Display (SMD)”** to disseminate the project related information. The procurement includes, supply of a P-10 “outdoor” SMD of (12x6) square feet size with mounts & supports and other necessary arrangements, its transportation to the project site, installation, commissioning and maintenance support for one year.

WAPDA invites sealed quotations from eligible firms/ companies/ individuals, registered with Income Tax/ Sales Tax Department and who are on “Active Taxpayers List” of the Federal Board of Revenue for “Supply & Installation of a surface mounted Display” at Dasu HPP, Kohistan.

Quotation validity:

Delivery requirements:

Address for delivery of the item is "Office of the project Director, Dasu HPP, Adjacent to PSO Pump, Main KKH Road, Dasu, Upper Kohistan, KPK".

Requirement of the Vender/Supplier.

- i. Assignment of dedicated contact person for contact with the client.
- ii. The Quotation in presecrbed format provided by vendor/supplier on company letter head should be signed and inclusive of all taxes.
- iii. Transportation to site & installation in the Project area is the responsibility of vendor/supplier.
- iv. Vender/supplier is responsible for provision of all kind of accessories attached to SMD Screen i.e Wall mount stand, Power supplies and cables etc.
- v. Short orientation/training for SMD operation should be given to client team.
- vi. One-year maintenance support will be provided by the Vender/supplier without any extra charges.
- vii. Vender/Supplier have to bear boarding and lodging charges for their team on site during installation and commissioning.

Conditions for the Client:


- i. Location information will be provided by client.
- ii. Client representative will be available for support and guidance during installation of SMD screen.
- iii. Logistic support and provision of computer system is the responsibility of client.
- iv. Dedicated operation room will be allotted by client in the premises where SMD screen will be installed.

3. All applicable taxes will be deducted from the quoted rate as per government rules.
4. 10% of the payable will be retained which will later be release after successful completion of the maintenance warranty period.
